How do I claim VAT correctly? Check your receipt

HMRC requirements are that in order to reclaim VAT (Tax) on purchases, you must have a VAT receipt Only VAT-registered businesses can issue VAT receipts and the VAT receipt must clearly show the suppliers VAT registration number It is best to ask suppliers upfront if they can provide you with a VAT receipt as you cannot claim

VAT To simplify the VAT treatment, the UK changed the rules effective 1 November 2017 to apply VAT based on the usual place of residence of the B2C customer After the change, UK VAT is no longer applicable to telco services used and enjoyed in the UK by non-UK B2C customers and VAT applies on supplies made to UK resident B2C customers
